












## 2.8 Percentage of First-Time, Full-time Degree/ Certificate-Seeking Students Receiving Financial Aid (Annual)\*\*






### 3.5 Timely Accumulation of Credits Trends (DHE, PMRS)\*\*\*




### 3.6 Persistence After First Year Trends (DHE, PMRS)\*\*\*\*




### 3.7 Timely Completion of Gateway Courses Disaggregated; 2023 (DHE, PMRS)\*\*








#### 4.4 Three-year Success Rates, All Degree/Certificate-Seeking Students




#### 4.5 Transfer to Baccalaureate within 4 years\* (DHE, PMRS)





This rate includes first-time and transfer students, full- and part-time, degree and certificate students, and non-degree students who earned at least twelve credits during their first two academic years. Success is defined as a student who earned a credential, transferred to a two- or four-year school, attained 30 credits and/or remained enrolled within six years of enrolling at a community college.

### 4.9 Earnings of Graduates Who Enrolled at Age 25 or Older (1, 3 and 5 years after completion)




\* Source notes: The Massachusetts Board of Higher Education (BHE) approved two post-enrollment earnings metrics in December 2018 for inclusion in the Performance Measurement Reporting System (PMRS). The metrics were developed in consultation with the Massachusetts Department of Higher Education's (DHE) data governance bodies and incorporated in PMRS in November 2025. The earnings measures are based on a match between Massachusetts public higher education student data from DHE's centralized postsecondary education data warehouse (HEIRS) and quarterly earnings records from the Massachusetts Department of Unemployment Assistance's (DUA) Unemployment Insurance database. Under a data sharing agreement among the Massachusetts education and labor and workforce development agencies, DHE obtains the earnings records from 2010 onward from DUA for individuals who have enrolled in Massachusetts public higher education using a secure matching process providing anonymized records back to DHE. DUA earnings data are limited to employment within Massachusetts and exclude self-employed individuals, military personnel, federal government workers, and persons employed out of state; DUA earnings data are aggregated by quarter and provide no indication of the dates or number of hours worked during said quarter.




### 5.1 Percent of Sections Taught by FT / PT Faculty




### 5.2 Percent of Sections Taught by Format Type



### 5.3 Percent of Sections Taught by FT Faculty, by Division




### 5.4 Average Section Size, by Division




### 6.1 Number of Full- and Part-Time Faculty and Staff




### 6.2 Number of Full-Time Faculty by Tenure Status






### 6.4 Race/Ethnicity of Recent Hires, FT Faculty












